GDPR Obligations & Rights

Subject Access Right

"...individuals have a general right, under Article 15, to ask and be told whether their data are being processed..." "...the individual has a right to receive a copy of their own data..."

Rights of Rectification/Erasure/Restriction "...entitles individuals to correct inaccurate personal data, including to add additional information." "...entitles individuals to have their personal data deleted if ..."

"...entitles an individual to block further processing of their data (including deletion) while a rectification or objection right is being processed, or as an alternative to erasure if the individual needs the data for a legal claim..."
